Commitment to achieving Net Zero

BIP Consulting UK Ltd. is committed to achieving Net Zero emissions by 2050.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reductions can be measured.

Baseline Year: 2023

Additional Details relating to the Baseline Emissions calculations.

BIP Consulting UK Ltd have completed an assessment of greenhouse gas emissions over the period of January to December 2023.

The inventory boundaries have been defined using an operational control approach. This includes the consultancy operations of BIP Consulting UK Ltd, but does not include emissions from subsidiary, sister, or parent companies.

BIP Consulting UK Ltd have re-baselined from their original 2019 baseline following an extensive restructuring of the business. The new carbon baseline also reflects new hybrid working conventions post-COVID which had not been fully reflected in the 2019 baseline. Future years will be assessed and compared against the 2023 results.

For reference the 2019 baseline figures were: 0 tCO2e for scope 1, 15.8 tCO2e for Scope 2 and 825.4 tCO2e for Scope 3.

Emissions are divided into scope 1, scope 2 and scope 3 emissions. Scope 2 emissions are reported using a market-based methodology. None of the electricity used in 2023 was from guaranteed renewable energy sources.

Our scope 3 emissions are reported as follows:

Emissions reduction targets


To continue our progress towards Net Zero Carbon, we have adopted the following carbon reduction targets in line with our wider groups' certified Science Based Targets Initiative (SBTi) commitments.

- We are targeting that scope 1&2 carbon emissions will decrease from 11 tCO2e to 6 tCO2e by 2030. This is a reduction of 43% from our baseline year of 2023.
- In alignment with the SBTi we are targeting 90% reduction in scope 1&2 by 2050 to 1.1 tCO2e.
- We are targeting that scope 3 carbon emissions will decrease from 435.6 tCO2e to 334.9 tCO2e by 2030. This is a reduction of 25% from our baseline year of 2023 across capital goods, employee commuting and business travel.
- We are targeting that scope 3 carbon emissions will decrease from 435.6 tCO2e to 44.7 tCO2e by 2050 across all categories. This is a reduction of 90% from our baseline year of 2023.

We project that our total carbon emissions will decrease over the next five years to 371 tCO2e by 2028. This is a reduction of 16.8%.

We also commit to offsetting our residual emissions annually from 2025. Making BIP UK carbon neutral from this year, and Net Zero by 2050.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

As we have updated our baseline to the current year due to organisational changes, we cannot provide evidence of emissions saved as a result of completed carbon reduction initiatives. However, this did not stop us from improving our impact on the planet by:

- Planning and specifying a new energy efficient and fossil fuel free office space.
- Continuing to encourage the hybrid working model to reduce travel and commuting.
- Continued reducing and diverting waste sent to landfill from operations. Maintaining separate waste and recycle bins in offices and providing education to remote working staff.
- Grew the environmental responsibility interest group to raise awareness of environmental impact through our Veganuary and Plastic Free July campaigns.
- Committed to Science based targets initiative on a group level.

In the future we hope to implement further measures such as:

- Moving office we plan to move to a more energy efficient and green office space where we control our energy use.
- Renewable energy: Look to use 100 % renewable energy (electricity Scope 2) in our environmentally friendly leased offices.
- Obtain ISO 14001 Environmental Management System-certification.
- Work with suppliers to reduce their carbon by introducing supplier environmental surveys.

A part of our structural changes we are reviewing our environmental management systems and looking to embed reporting and monitoring programs into our day-to-day activities.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.
